# Genesis 6-9

- As with much of the opening chapters of Genesis, 6-9 are often ridiculed, attacked and misunderstood...
- But God is not the author of confusion!
  - 1 Cor 14:33
- Ch 6 – The reason & warning for the Flood
- Ch 7 – The Flood
- Ch 8 – A new world
- Ch 9 – A new covenant

# Genesis 6-9

- If there once was a worldwide flood, what would the evidence be?
- *Why* would God allow His Creation to be destroyed by a worldwide flood?
  - In Gen 1:31 God declared creation ‘very good’
  - Yes, we had the murder of Abel...
  - We’ve seen the beginning of sexual excess,
  - ...clearly some of the world had tuned away from God and blasphemed His name.
  - But isn’t *destroying* the world extreme??
  - Something very serious was going on!

# The God of the OT?

- In *The God Delusion*, Richard Dawkins says,
- *"The God of the Old Testament is arguably the most unpleasant character in all fiction: jealous and proud of it; a petty, unjust, unforgiving control-freak; a vindictive, bloodthirsty ethnic cleanser; a misogynistic, homophobic, racist, infanticidal, genocidal, filicidal, pestilential, megalomaniacal, sadomasochistic, capriciously malevolent bully."*



# Rules of Interpretation

- The Golden Rule:
  - *When the plain sense of scripture makes common sense, seek no other sense; therefore, take every word at its primary, ordinary, usual, literal meaning, unless the facts of the immediate context, studied in the light of related passages and axiomatic and fundamental truths, indicate clearly otherwise*



# Rules of Interpretation

- The Law of Double Reference:
  - *This law observes the fact that often a passage or a block of Scripture is speaking of two different persons or two different events that are separated by a long period of time.*

*“But as the Days of Noah were,  
so shall also the coming of the  
Son of Man be.*

Matthew 24:37

# Rules of Interpretation

- The Law of First Mention:
  - *This law states that the first time a word or idea is used in Scripture is usually indicative of its meaning in subsequent usages.*
- The Law of Expositional Constancy:
  - *This law states that the Bible is consistent with its use of ideas or figures throughout the Bible (eg 'fowls of the air' as seen in Matt 13 are 'workers of iniquity' and whenever fowls are seen in Scripture they are usually seen in this light.*

# Rules of Interpretation

- Scripture is self interpreting:
  - *Any passage of scripture that on the surface may seem to be difficult to understand will be explained elsewhere in scripture, thus eliminating guesswork and human opinion as to its meaning*

# Flood Legends

- 270+ records
  - 88% favoured family saved
  - 70% survival by a boat
  - 95% sole cause was a Flood
  - 66% man's wickedness was the cause
  - 77% animals were also saved
  - 57% survivors end up on a mountain
- Many say a bird was sent out
- Many say 8 people saved
- Many record a rainbow
- Many have a record of a man named Noe

# The White Cliffs of Dover



- The cliffs are composed primarily of coccoliths,
  - plates of calcium carbonate formed by coccolithophores, single-celled planktonic algae
- The current rate of erosion is 0.39" per yr
  - with a height of 350' gives us a current height of 4200"
  - The cliffs would be gone in 10,769 yrs.
- What else but a worldwide Flood can explain this?
- Did all these creatures just decide to go to Dover to die?
- Or were they sifted and deposited by the violent global shakeup at the time of the Flood?



# What would the evidence be?

- Twisted and bent rock strata, deposited when soft, then hardened
- Rock does not bend! This could not happen gradually!



# What would the evidence be?

- Evidence of mass erosion as the water ran of the earth



- A little bit of water and a lit of time?
- OR a lot of water and a little bit of time!

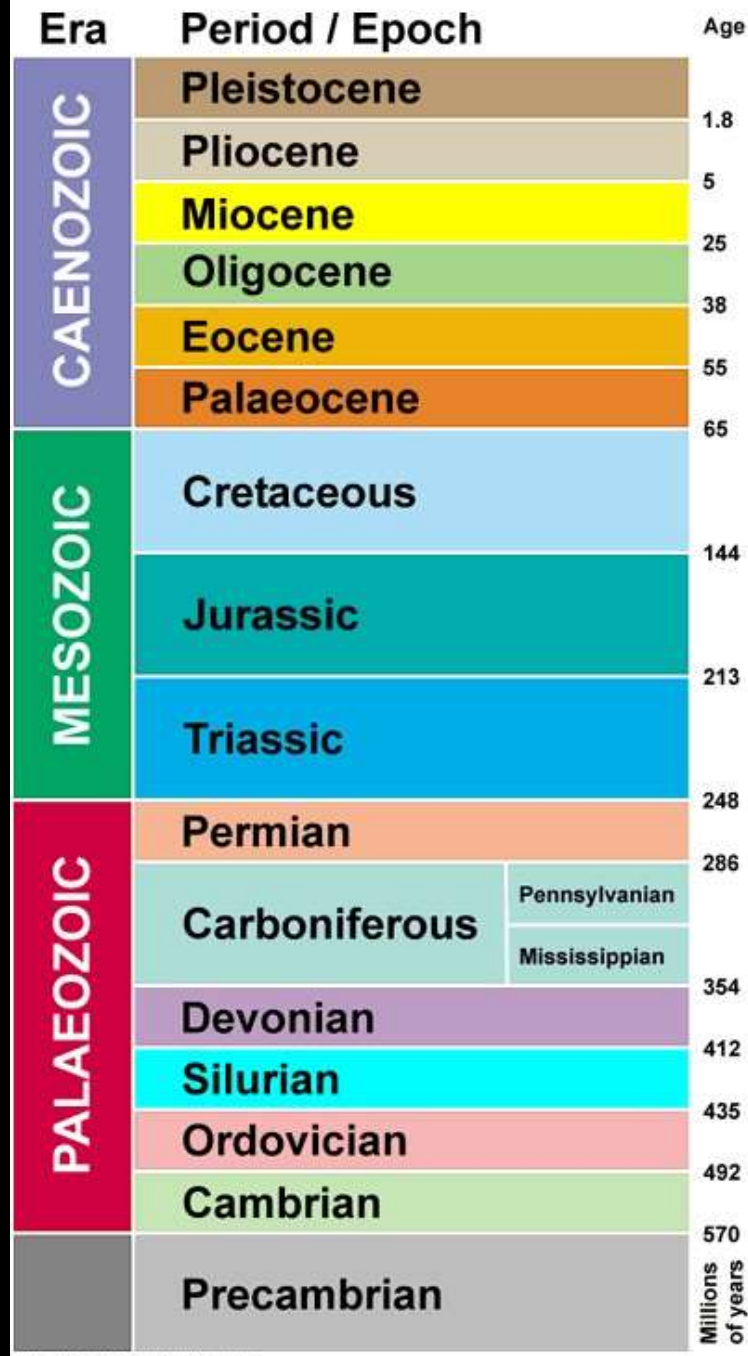
# What is currently claimed?

- Geologic column
  - No evidence exists
- The belief in 'Millions of years'
  - Only supported by geologic column
  - Carbon Dating can only date living/once living material
    - even then can date no further back than 50,000 years
    - All Carbon 14 would have decayed beyond trace by then
    - Why is there still Carbon 14 found in coal???
      - If coal is millions of years old, it should of all gone!

# What is currently claimed?

- Uniformitarianism
  - Brutally assaulted by the evidence to the contrary
  - This only gained popularity by those wanting to promote Darwinian Evolution which required millions of years

# James Hutton

“James Hutton (b.3 June 1726 in Edinburgh) was a Scottish geologist, noted for formulating uniformitarianism and the Plutonist School of thought. He is considered by many to be the father of modern geology”

**Plutonic theory** is the geologic theory proposed by James Hutton around the turn of the 19<sup>th</sup> century that volcanic activity was the source of rocks on the surface of the Earth. It was named for Pluto, the ancient Roman god of the underworld. This replaced Abraham Werner’s Neptunism theory, which claimed that rocks had originated from a great flood and were basically sedimentary in origin.

**Uniformitarianism** is one of the most basic principles of modern geology, the observation that fundamentally the same geological processes that operate today also operated in the distant past. It exists in contrast with catastrophism, which states that Earth surface features originated suddenly in the past, by geological processes radically different to those currently occurring

Observation? You cannot observe the past!

# Charles Lyell

Charles Lyell was born in Kinnordy, Angus, (Scotland, in 1797)

Having attended Exeter College, Oxford ending in 1816, Lyell encountered geology as a serious profession under the wing of the naturalist William Buckland. By 1827 he had abandoned the law and embarked on a long geological career that would result in the widespread acceptance of the ideas **proposed by James Hutton a few decades before**

*Principles of Geology*, Lyell's first book, was also his most famous, most influential, and most important. First published in three volumes in 1830-33, it established Lyell's credentials as an important geological theorist and introduced the **doctrine** of uniformitarianism. The central argument in *Principles* was that "the present is the key to the past:"



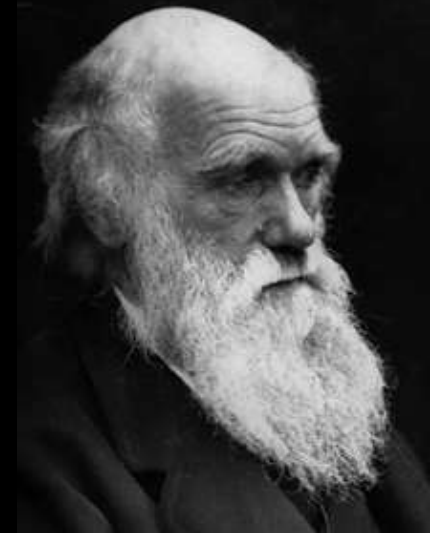

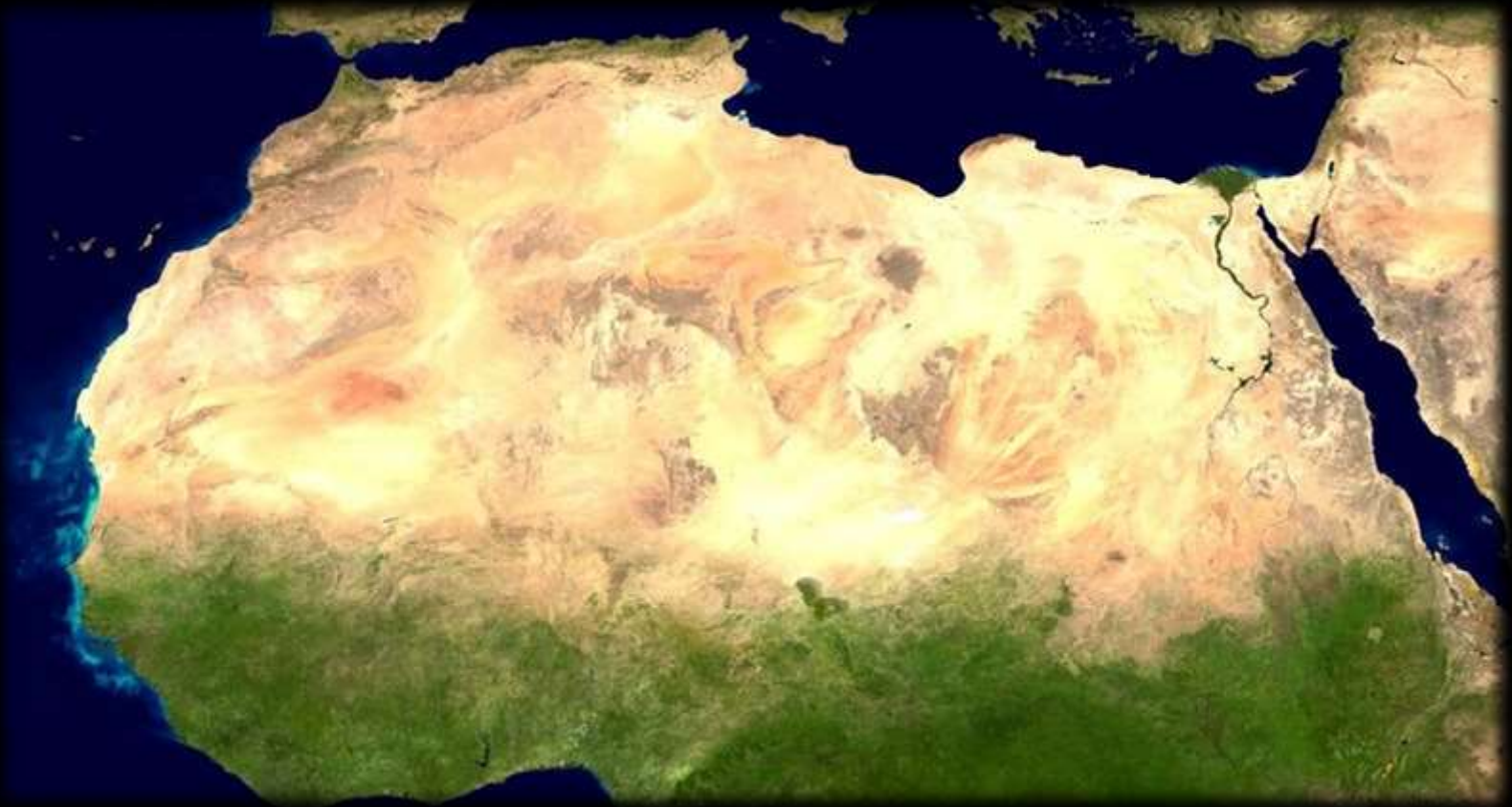

# The World's Population Increase

- Why is the world's population consistent with a young earth and not at all consistent with the evolutionary timescales?
- If 8 people came off the ark 4400 yrs ago, this makes sense.
- If man has been on earth for millions of years it does not!



# Not Enough Bones!

The evolutionary scientists who believe that man existed for over a million years have an almost insurmountable problem. Using the assumption of forty-three years for an average human generation, the population growth over a million years would produce 23,256 consecutive generations.



# Not Enough Bones!

We calculate the expected population by starting with one couple one million years ago and use the same assumptions of a forty-three-year generation and 2.5 children per family....The evolutionary theory of a million years of growth would produce trillions x trillions x trillions x trillions of people that should be alive today on our planet.

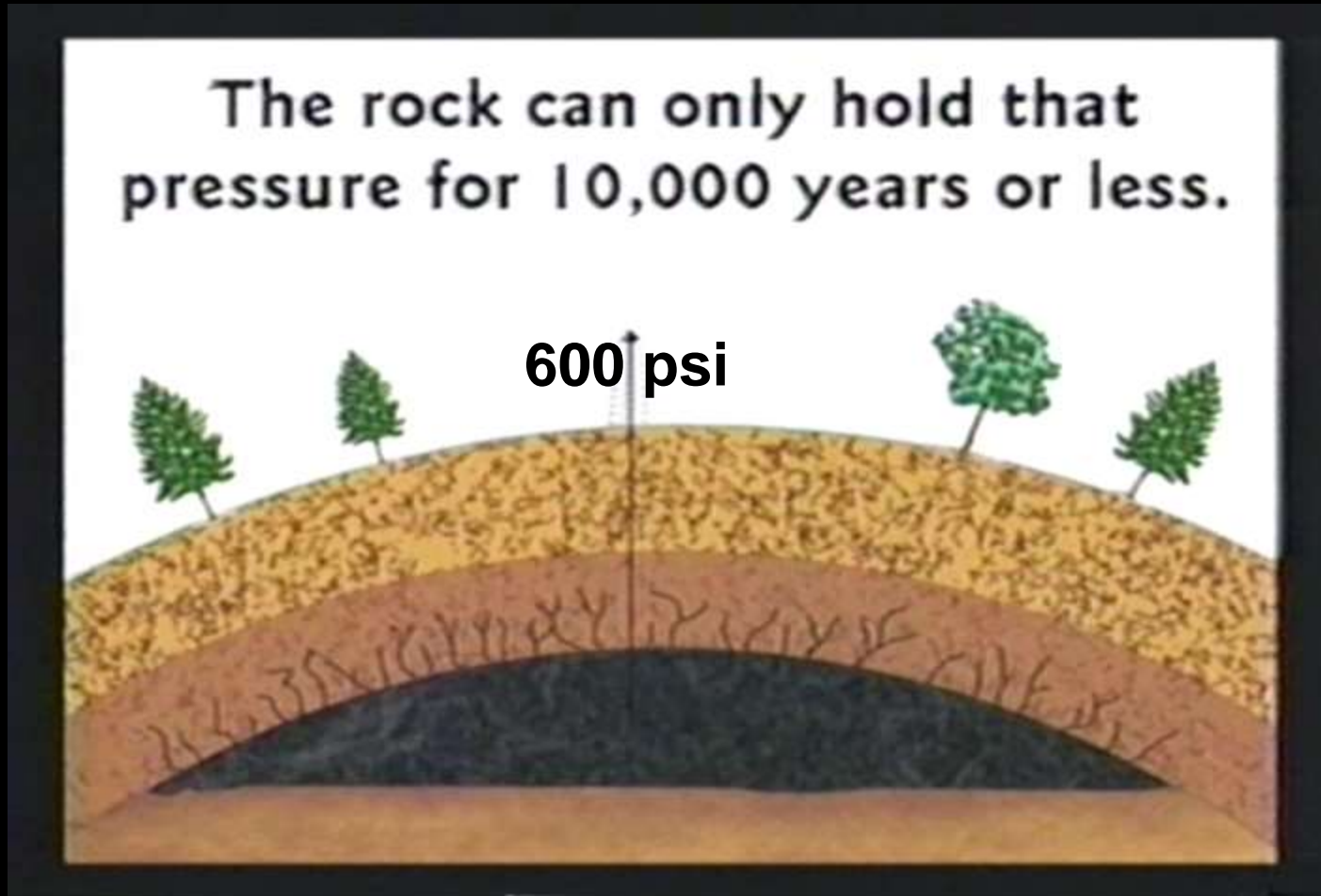

# The Reason for the Flood

- Angelic beings had 'left their first estate'
- They had desired and taken women
- Their offspring were hybrid beings
  - part human - part celestial
- They were of abnormal size
- They were called 'Nephilim'
  - 'the fallen ones' /
    - Hebrew verb: 'Nephal' to cast down
- The (Greek) Septuagint translates this as 'giants' – from 'gigas' (earth born)

# The Reason for the Flood

- *Genegees* is the same word used in Greek mythology for “Titans,”
- creatures emerging from interbreeding of the Greek gods with human beings. *Genea*, means “breed,” or “kind.”
- The English words “genes” and “genetics” come from the same root.

# The Reason for the Flood

- They become the source of much myth and legend
- BUT...
- The real purpose was the annihilation of the human race
- ONLY Noah (and family) had kept themselves 'genetically pure'
  - uncontaminated
- Satan almost succeeded in destroying mankind.



# The Reason for the Flood

- Was God unjust & unloving to send the flood?
- NO!...
- It was an incredible act of love and mercy to preserve His 'special creation'
- Psalm 119:68 – God is good

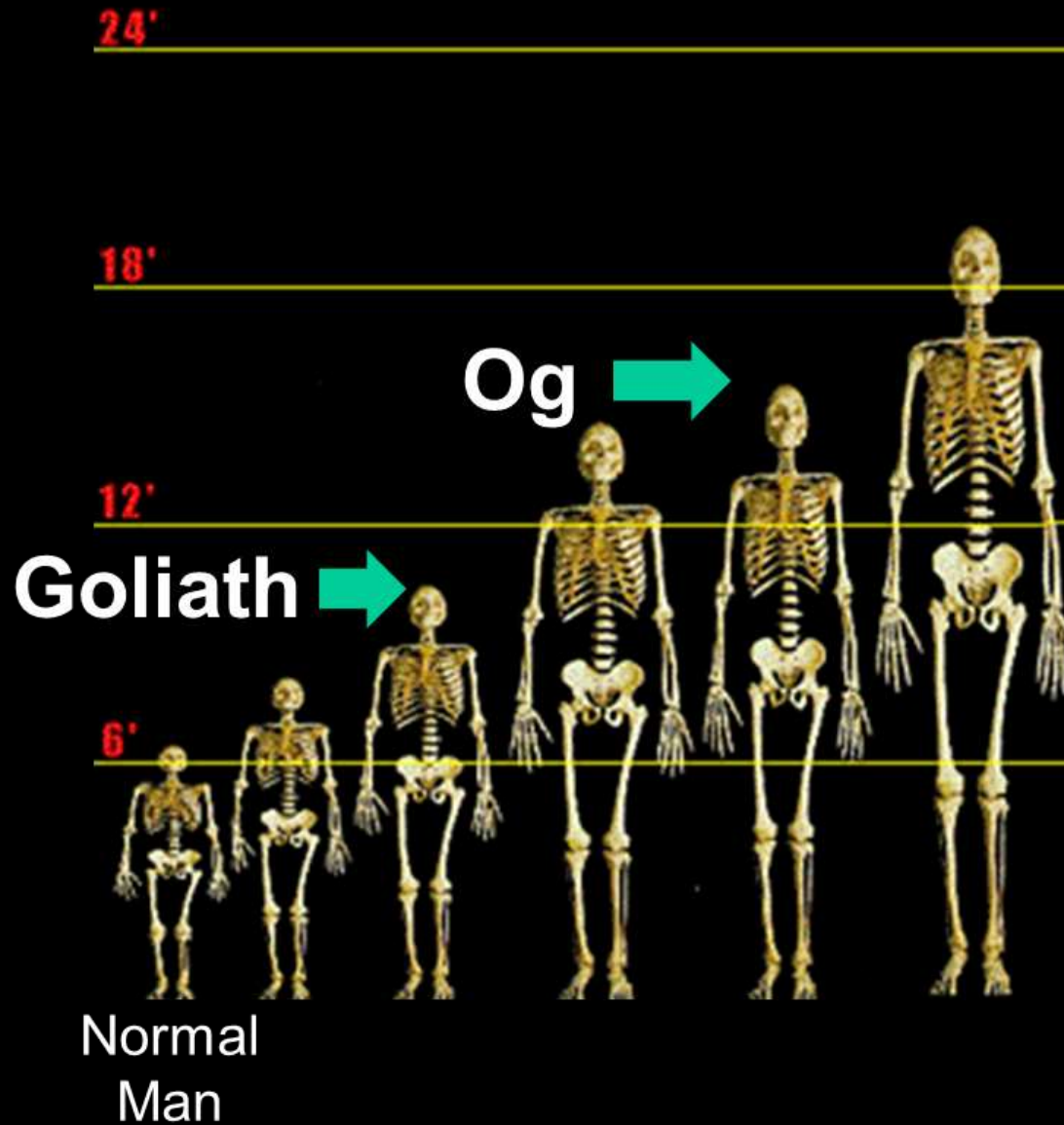
# Also after that...

- Tribes of giants were in the Land in Abraham's time, 2000 BC - Gen 14:15
- Remnants of them existed as late as the times of Moses (1400 BC) and David (1000 BC)
  - Numbers 13:33;
  - Deuteronomy 2:10,11,20,21;
  - Joshua 12:4; 15:8; 17:15; 18:16;
  - II Samuel 21:16-22;
  - I Chronicles 20:4-8.

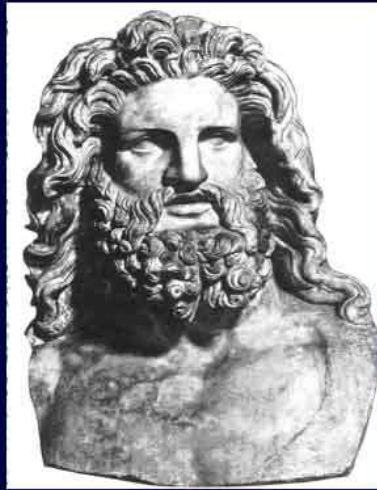
# Also after that...

- The iron bedstead of Og the Ammonite (ruler of a nation of giants) was 15.4 ft long - Deut 3:11,13
- Goliath (1000 BC), from a family of giants,
- more than 10 ft tall 1 Sam 17:4
  - He wore a breastplate of mail weighing 5,000 shekels (126 pounds or 57 kilograms) as well as a spear, like a "weaver's beam". The spearhead, when weighed by itself, tipped the scales at 600 shekels (approx 15 lbs or 7 kg)
- Beniah, a hero of David's army, slew an Egyptian giant who was 8½ feet - 1 Chron 11:23

## “The Circle of Rephaim”

- 5 circles including 20-ton stones,  
(Diameter =155 meters )
- Dated: 3000 BC
- Built on flat plateau; only visible from above
- 10 miles from Asteroth-Karnaim

# Ancient Mysteries

- *Gigantic worked stones, including enormous stones set into buildings: eg*
  - *200 ton blocks at Ollantaytambo and Ollantayparubo, Peru.*
  - *100 to 200 ton foundation and wall blocks of Tiahuanaco, Bolivia.*
  - *340 ton 65 feet high standing stones of Brittany, France.*
  - *2000 ton foundation stone, and 1000 ton 180 foot stones fitted 20 feet up in the building at the Temple of Jupiter, Baalbek, Lebanon*

# Ancient Mysteries

- *Gigantic worked stones, including enormous stones set into buildings: eg*
  - *50 to 300 ton blocks of Sacsayhuamen, Peru, fitted precisely without cement*
  - *20,000 ton block the size of a 5-storey house in same locality.*
  - *50 ton building blocks transported across a lake in Mexico*
  - *Walls 40 feet thick, Chan Chan, Peru*
  - *50 ton building slabs, in the Amazon jungle*

# Ancient Mysteries

- *Gigantic worked stones, including enormous stones set into buildings: eg*
  - *Stone heads the size of a 7-storey building, cut, moved and erected, on Easter Island*
  - *25 to 50 ton blocks at Stonehenge, England*
  - *233 20,000 pound geometrically shaped blocks at El Enladrillado, Chile*
  - *23 foot thick walls at Magdalensburg, Austria*
  - *240,000 pound 30 foot long stone crosspiece above an 18 foot high door, in Peloponnesus, Greece*



# Ancient Mysteries

- *Gigantic worked stones, including enormous stones set into buildings: eg*
  - *50 feet thick walls at Tiryns, Greece*
  - *170 ton stone tomb on Tonga Tabu, Pacific Ocean*
  - *65 foot giant statues and one 900 ton 70 foot high statue with a big toe 3 feet long, at Thebes, Egypt*
  - *40 ton monolith on Vanua Levu, Fiji*
  - *65 foot high columns on Rimatara*
  - *Statue 18 stories high, Bemian, Afghanistan*
